Sandiganbayan Justice Gomez-Estoesta **Appointed as New Court Administrator**

The Supreme Court En Banc has appointed Sandiganbayan ociate Justice Ma. Theresa Dolores C. Gomez-Estoesta as the new Court Administrator, effective September 1, 2025. She replaces former Court Administrator Raul B. Villanueva, who is now an Associate Justice of the Supreme Court



Justice Gomez-Estoesta has served the government for 34 years. She began her career as a Solicitor at the Office of the Solicitor General from 1991 to 2002.

She joined the Judiciary in 2002 as Presiding Judge of Branch 6, Metropolitan Trial Court, Manila. In 2006, she was promoted as Presiding Judge of Branch 7 of the Ma-nila Regional Trial Court. She held this position until 2014, when she was appointed to the anti-graft court.

At the Sandiganbayan she served as Chairperson of the Seventh Division.

The Office of the Court Administrator (OCA) was created under Presidential Decree No. (PD) 828, as amended by PD 842, to help the Supreme Court manage and supervise all courts na-tionwide.

As part of the Strategic Plan for Judicial Innovation 2022-2027 (SPJI), the OCA is currently undergoing modernization to make it more responsive, service-focused, and better supported across regions.

Central OCA Leadership Team, headed by the Court Administrator, will take the lead in setting overall strategy, policy direction, and innovation initiatives for the trial courts. At the same time, court administrative functions are being decentralized to the newly established Office of the Regional Court Manager (ORCM) across all judicial regions. The Department of Science and Technology Region 1 (DOST Region 1), in partnership with the DOST-Science and Technology Information Institute (DOST-STII), officially held the 2025 National Science, Technology, and Innovation Week (NSTW) Media Kickoff on September 8, 2025, at Harolds Hotel, Quezon City

Ipinapaliwanag ng PHI-VOLCS na ang mga volcanic-tectonic earthquakes na ito ay nagpapahiwatig ng paggalaw sa ilalim ng bulkan. Ang lakas ng mga nai-

talang pagyanig ay nasa pag-itan ng Magnitude 0.8 hang-gang Magnitude 3.6.

Ang pinakamalakas na pagyanig sa mga ito ay naitala sa Intensity I sa La Carlota City, Negros Occidental at Canlaon City, Negros Oriental.


