DOST brings nat'l science, technology, and innovation week in Cagayan de Oro City

The Department of Science and Technology is set to hold the 2024 National Science, Technology, and Innovation Week celebration in Cagayan de Oro City from November 27 to December 1-a first in Mindanao. The NSTW highlights the significant contributions of science and technology to national development and has become a platform for heralding S&T advocacy in the country.



This year's celebration is anchored to the theme "Siyensya, Archicolohiya, at Inobasyon: Kabalikat sa Matatag, Maginha at Panatag na Kinabukasam' and the subtheme "Providing Solutions and Opening Opportunities in the Green Economy."

The five-day event will showcase the DOST's initiatives cores four strategic pillars: promotion of Human Well-being, Wealth Creation, Wealth Protection, and Sustainability. DOST will also recognize awardees as critical contributors to Science, Technology, and Innovation. It is expected to attract over 10,000 attendees, including local government units, startups, enterprises, legislators, executives, students, and the general public.

The NSTW will be celebrated by conducting over 33 forums at the Luxe Hotel and other nearby hotels in the City. There will also be a display of the NuLab: Stem in Motion, where students can experience a roving laboratory with brief lectures, the Mobile Modular Food Processing Facility, and the Makile Companyed and Cortal Vabiles.

A massive expo of at least 150 technologies and innovations will also be showcased at the Atrium and East Concourse of Limketkai Center, featuring various immersive platforms, 3D prototypes, robotics, sound domes, and many others—mainly something new in the region. Scholars and Startup Pitching competitions will also happen at Cinema 4 in the mall.

Program Initiatives for Smart and Resilient Communities and feature the activities and recognition of partners in the World Records Attempt led by DOST 10 on "Most number of people planting bamboo simultaneously in multiple locations." Confirmed attendees and interested participants can easily

The NSTW is celebrated through Proclamation No. 2214 series of 1982 issued by then-President Ferdinand E. Marcos, Sr.. It was amended by then-President Rodrigo R. Duterte through Proclamation No. 780 in 2019 to be celebrated every fourth week of November for maximum participation.

The Regional Development Council also supports this event through Resolution No. 66, s. 2024, titled "Enjoining the Regional Line Agencies, Private Sector and Industries, Academe, and Local Government Units to Support and Participate in the National Science, Technology, and Innovation Week

Sara Duterte says she prefers peace and development programs instead of dole-outs

Vice President Sara Duterte said on Wednesdent that development programs aimed to uplift the lives of the ordinary Filipinos hold greater significance than dole-outs or mere financial aid.

This is amid the current administration's extensive



distribution of financial assistance across the country to help Filipinos make ends

Duterte responded when asked by the media in Butuan City whether the assistance will continue next year, considering that their budget is being scrutinized by the Senate and Congress

ate and Congress.

"Sa Office of the Vice
President, wala kaming ayuda. Pag mayroong humihingi
sa amin ng ayuda, we usually
refer it to DSWD because ang
prinsipyo namin, hindi dapat
ayuda ang ibinibigya sa tao
na nangangailangan, dapat
binibigyan siya ng mapayapang pamumuhay, oportunidad
para makapag-negosyo, oportunidad para makapaghanap
ng trabaho," she said.

However, the vice president said they also have medical assistance, as well as grocery packs, which will be

given in time for gift-giving this Christmas season.

Duterte believes that good governance is still essential to the progress of the country.

"We still believe, and it is our platform, and it is in our budget na good governance is the key to nation building. So hindi naussolusyonan ng ayuda yung problema ng mga tao lalong lalo na sa mga kapos ang pang araw-araw, lalo na sa kawalan ng trabaho, at safety and security and well-being ng tao," she said.

Duterte also recalled her state as Davao City mayor, when they focused on implementing peace and development programs rather than dole-outs.

"Isa pa pud sa akoang

"Isa pa pud sa akoang kuan nianing ayuda kay mura ba siya'g insulto sa kawad-on sa tao nga mura ba'g, 'Wala man ka, o P5,000 lang imoha, human na ta.' Murag ingon ana ba. Sa panan-aw nako, ang trabaho sa gobyerno, paniguraduhon nga dunay oportunidad ang mga tao kontra sa hatagan nimo siya og doleout." she said.

Meanwhile, Duterte said that the Office of the Vice President will continue to bring aid, through their disaster operations centrer, in areas affected by series of tropical cyclones, such as Bicol region and Northern Luzon.\()
Humanitarian activities

Humanitarian activities will continue, she said, despite the ongoing activities in line with the celebration of the 89th anniversary of the OVP.

Regarding the House investigation into the office's budget, Duterte stated that it is up to the staff or officials to decide whether to attend, as they will also offer assistance if invited.
