#### JURISDICTION OVER

GRAFT CASE VS. GUO
Remulla said they are
still awaiting the reply of the Office of the Ombudsman. He wrote to the Ombudsman to seek clarification over the graft case filed against Guo in a Capas Regional Trial Court. Remulla earlier said the

case should have been filed before Sandiganbayan.

"We expect them to re-

spond to our letter very soon. We also intend to write a letter to the court administrator so that all these confusion will be done away with. We cannot allow these things to happen again. I don't think we want a conflict of jurisdiction for any person we want tried for different crimes. So dapat ito maging clear," he said.

"The Capas court cannot take precedence over what the Sandiganbayan should be doing. This is a case of a really, a court issuing an order without jurisdiction," the DOJ chief added. Remulla admitted he was

not comfortable knowing the case against Guo was filed in a court within Tarlac, wherein she was a mayor of a municipality.

Quiboloy's camp said
it filed a motion in court requesting to transfer him to the custody of the Armed Forces of the Philippines from the Philippine National Police.

KOJC chief legal coun-sel Israelito Torreon said the move is out of concern for Quiboloy's safety.

The Department of Na-tional Defense on Monday rejected the proposal seeking the transfer of the religious

BOLOY'S FACE BEING HIDDEN

Remulla again ques-tioned the way Quiboloy's presentation to the public was handled by police.

He maintained that the KOJC leader's face should not have been completely covered when he was presented to the media by the national police

The PNP also drew flak online for releasing blurred versions of the mugshots of Quiboloy, which some be-

lieve were "special treatment since he is a high-profile in mate

The DOJ chief believes the police should be fair with these procedures.

PETITION FOR NATURALIZATION Petitioner Yukio Mizoguchi, by counsel,1 unto this Honorable Court, most respectfully states

Petitioner, whose complete name is Mizogu chi, Yukio Hasegawa, was born on January 15, 1955 in Hyogo Japan to parents Yayoi Mizogu-chi and Hachiro Mizoguchi. A copy of Petition-er's Certificate of Birth is hereto attached and made an integral part hereof as Annex "A"

- 2. Petitioner is a citizen of Japan, a country whose laws grant Filipinos the right to become naturalized citizens thereof. The petitioner is registered as a resident alien and possesses an alien certificate of registration (ACR) from the Bureau of Immigration. A copy of his ACR hereto is attached as Annex "R"
- Petitioner's first recorded arrival date in the Philippines was on April 08, 1977, at the Manila International Airport based on his available old passport, attached hereto as Annex "C". However, according to the records of the Bureau of Immigration of the Philippines, his first arrival date in the Philippines was on June 20, 1994, aboard a Thai Airways plane with flight number TG62. A certificate of arrival issued by the Bureau of Immigration of the Philippines on September 08, 2017, attached hereto as Annex "D".
- 4. Petitioner has continuously and permanently resided in the Philippines since his arrival and has been residing at No. 107 Dayap St., Ayala Alabang, Muntinlupa City, for at least one (1) year prior to the filing of this Petition. A copy of his Residence Certificate issued by the Barangay of Ayala Alabang Muntinlupa is attached as Annex "E".
- 5. Petitioner is one of the directors and the majority stockholder of the Daruma Corpora-tion, a domestic corporation duly organized and existing under and virtue of the laws of the Republic of the Philippines with principal office address at Daruma Bldg. No 2015 Senator Gil Puyat Avenue, Pasay City, Copies of this Annual Income Tax Returns for the years 2021, 2022, and 2023, are attached hereto and made integral parts hereof as ANNEXES"F,"
  "G," and "H." Copy of Bank Certification, as
  ANNEX "I".
- 6. Petitioner speaks and writes English and
- 7. Petitioner has been married since May 16, 1982, to Eden Villanueva-Mizoguchi. in Manila. A copy of the Marriage Certificate as **ANNEX-ES** "J".
- Petitioner is entitled to the benefit of Section 3 of the Revised Naturalization Law (Commonwealth Act No. 473) reducing to five (5) years the requirement under Section 2 of ten (10) years of continuous residence.
- 9. Petitioner and his wife begot three (3) children, namely Hideo, Keiko, and Kenji, who were born on May 29, 1983; November 21, 1984; and August 17, 1986, in Manila respectively. Petitioner does not have any minor children required to be enrolled in any public or private schools recognized by the Department of Education or Office of the Private Education of Education or Office of the Private Education of the Philippines, where Philippine History, gov-ernment, and civics are taught or prescribed as part of the school curriculum. Copies of the birth certificates are attached hereto as AN-NEXES "K", "L", and "M", respectively.
- 10. Petitioner is exempt from the requirements of Section 6 of the Revised Naturalization Law (Commonwealth Act No. 473) regarding the filing with the Office of the Solicitor-General a declaration under oath of his bona fide in-tention to become a citizen of the Philippines, as he has been residing in the Philippines for more than 30 years prior to the filing of this Petition. However, despite being exempted from filing the Declaration of Intention before the Office of the Solicitor General, the Petitioner still filed the same. Copy of the declaration of in-tention received on November 10, 2027, by the Office of the Solicitor General attached hereto as ANNEX "N".

- 11.Petitioner possesses all the qualifications under Section 2, and none of the disqualifications under Section 4 of the Revised Natural-
- 11.1.Petitioner believes in the principles un-derlying the Philippine Constitution; is of good moral character and has conducted himself in a proper and irreproachable manner during the entire period of his residence in the Philippines in his relations with the constituted government as well as with the community in which he lives; has mingled socially with the Filipinos, and has evinced a genuine desire to learn and embrace the customs, traditions, and ideas of the Fili-


