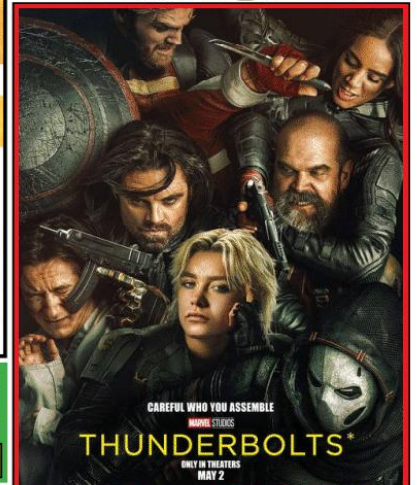

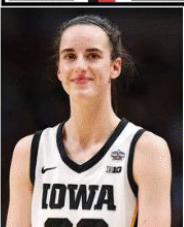

DOST trains 14 Jasaan milk producers on food safety and good manufacturing practices



In its mission to enhance its production standards, the United Livestock Raisers Cooperative (ULIRCO) underwent training on Food Safety and Good Manufacturing Practices (GMP) from the Department of Science and Technology—10 (DOST 10).

ULIRCO is a National Dairy Authority-supported group that produces pasteurized milk under the brand name "Fresh Moo" in Jasaan, Misamis Oriental.

Fourteen staff and on-the-job trainees attended the training from DOST 10 on September 10, 2024.

ULIRCO, a recipient of DOST's Small Enterprise Technology Upgrading Program (SETUP), had previously benefited from milk processing equipment and laboratory analysis services provided through the program in 2022. The cooperative also received consultancy support through DOST's Manufacturing Productivity Extension Program (MPEX). The cooperative is obtaining the FDA License to Operate (LTO) and Certificate of Product Registration (CPR). These certifications are crucial as they will enable ULIRCO to expand its product range and reach larger markets, including regional mall outlets, thereby increasing its market share and revenue.

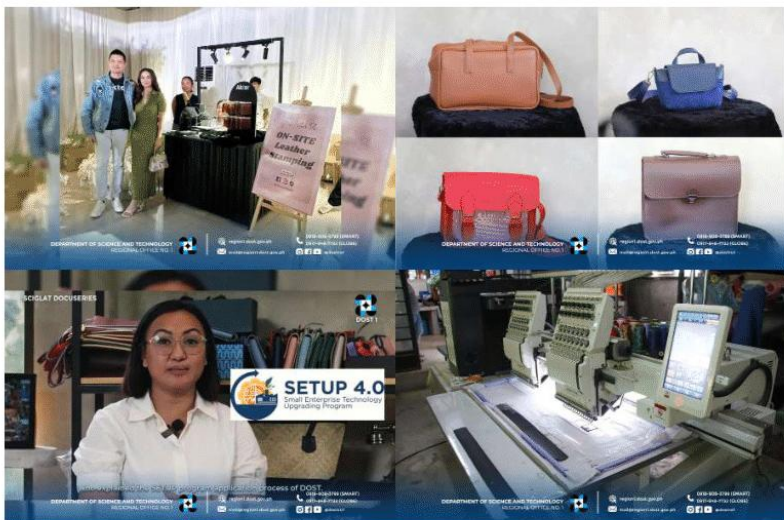

Niña Leather PH, founded by Niña Angelica C. Matias, stands as the first leather production firm in the province, a pioneering venture in an area previously unexplored for leather craftsmanship.

Nina's journey began in Marikina, a city renowned for its high-quality leather goods. Working as a corporate employee, she frequently bought Marikina's leather products as "pasalubong" for her loved ones in Ilocos Norte. This deep appreciation for Marikina's craftsmanship inspired her to bring the tradition to her hometown.

In 2016, Nina took a leap of faith and founded Niña Leather PH in her garage. She devoted herself to mastering every aspect of leatherworking, from cutting and stamping to sewing. Despite initial skepticism about whether she could market Marikina-inspired leather goods in Ilocos Norte, her perseverance paid off. The business thrived, leading to an increased demand that necessitated hiring additional staff and expanding production capabilities.

However, the COVID-19 pandemic posed severe challenges, as the non-essential goods sector suffered a decline. In response, Nina adapted by producing "inabel" masks in collaboration with local weavers, supporting her staff and community during a difficult time.

As the pandemic waned and demand for her products surged again, Niña Leather PH faced a critical need for expanded production capacity.

This was when the Department of Science and Technology Region 1 (DOST-1) came to their aid. Recommended by Sir Lawrence from T-Shirt Factory, a DOST SETUP beneficiary, Niña Leather PH was introduced to DOST 1-PSO Ilocos Norte, under the guidance of Provincial Director Benjamin S. Mercado.

The DOST's Small Enterprise Technology Upgrading Program (SETUP) provided vital support through assessments, energy audits, and personnel training. The assistance included acquiring two heads of fully computerized embroidery machines and a UV printer, which significantly boosted production efficiency, product quality, and operational capabilities.

The impact of DOST 1's support was transformative. Niña Leather PH achieved a 22 percent increase in production, a 6 percent boost in productivity, and a 22 percent rise in sales. Their client base expanded by 13 percent, reaching not only within the province but also nationally and internationally. The firm also contributed to the local community by hiring single parents and elderly individuals and creating valuable employment opportunities.

Niña has said she is grateful to DOST 1 for their crucial role in the firm's growth and encouraged other entrepreneurs to leverage the opportunities provided by DOST.

VP Duterte can step down if she is no longer interested in performing her duties: solon



Vice President Sara Duterte can "step down" if she is no longer interested in performing her duties and functions, according to a Vice Chairperson of the House Committee on Appropriations, citing her repeated absence in the budget deliberations of the House of Representatives.

House Deputy Speaker and Quezon 2nd District Representative David Suarez said this sentiment is shared by "a lot of members" of the lower chamber. Last September 10, Duterte snubbed the resumption of the House Committee on Appropriations' deliberations on the OVP's budget. She also did not show up in the September 23 House plenary debates, when the OVP was scheduled to be tackled.

"Consistent naman po 'yung Vice President natin, in fairness to her. Consistent in the sense na hindi siya dumalo noong Committee on Appropriations budget hearing, pati dito sa plenary, hindi dumalo. It shows that she's not interested with her duties and functions as the Vice President of the Philippines. Kung ganyan ang lumalabas, probably we can ask her to step down as the Vice President," AKO BICOL Party

List Representative Raul Angelo Bongalon said.

"Mas pinili niya pang pumunta sa isang beach resort kesa dumalo dito sa pagding sa kanyang budget. So I guess it's the Filipino people. It's up to them to judge the Vice President," he added.

The Office of the Vice President said stories claiming Duterte was supposedly on a beach while the OVP's proposed 2025 budget was scheduled for plenary deliberations at the House of Representatives on Monday are an attempt to "besmirch the reputation of the Vice President." The OVP said Duterte made stops in Camarines Norte and Albay to talk to the people there.

In their statement, the OVP noted that Duterte sent a letter to its budget sponsor at the lower house last September 11, to reiterate that the OVP leaves the deliberation of its budget proposal in the

plenary "entirely to the pleasure of the House of Representatives".

But according to 1-RIDER Party List Representative Ramon Rodrigo Gutierrez, the letter did not state that Duterte will not attend or that she will send an authorized representative. The representative sent by the OVP on Monday had no written authorization, prompting the lower chamber to reschedule the plenary debates on its budget to Tuesday.

BETRAYAL OF PUBLIC TRUST?

Two lawmakers called Duterte's repeated absence to defend her office's budget utilization before the lower chamber a "betrayal of public trust". Despite this, lawmakers said impeaching the Vice President has not been discussed at the lower house. "Technically, it is in a way, betrayal of public trust,

but whether it would amount to impeachment, masyadong malayo naman po 'yun," Gutierrez explained.

"Sa majority, wala kami napag-uusapan tungkol sa impeachment, hindi natin iniisip 'yan," House Assistant Majority Leader Jefferson Khonghun added.

NO REENACTED BUDGET

Congressmen said they will wait until Wednesday for the Vice President or an authorized representative of her office. If either of the two do not show up, Suarez said the House will just "cross the bridge when it gets there."

But they said a reenacted national budget for next year is unlikely. "I don't think that is within any real means because so far naman all the other departments and agencies have fully complied with the requirements of the law," Suarez said.

"It's just a procedural issue, the budget process of Congress is slowing down to accommodate certain personalities to appear, to be heard, to be fair, to be lenient. And I think the leniency afforded on this procedural issue will have its limit and we will not sacrifice the budget for the sake of this procedural lapse. The substantive must reign and still we will pass this budget. What we're trying to say here is that the budget would wait for no man. But in this case, it is a woman," Gutierrez added.

"Kung ang tingin ng ating vice president eh kaya niyang isabotahe 'yong pagpasa ng budget ng ating pamahalaan for 2025, hindi po papayagan ng Kongreso 'yon," Khonghun noted. Some lawmakers also expressed relief that Duterte previously resigned from her post as Education Secretary.

"Buti na lang at si Secretary Angara na 'yong Secretary ng Department of Education," Khonghun said.

"Siyempre kung ito 'yong ugali niya bilang OVP tapos assuming na hindi siya nag-resign, eh 'di ano'ng nangyari sa budget ng DepEd? Isang milyon na teachers yata ang umaasa sa DepEd budget, at saka hindi lang 'yong mga teachers, 'yong mga bata, 'yong mga paaralan, 'yong mga magulang na umaasa sa maayos na edukasyon," Suarez added.

The House of Representatives targets to pass on final reading the proposed 2025 national budget on Wednesday. It terminated on Tuesday the plenary debates on the proposed budget of the Office of the President and the Department of Education.



Senate panel frees Shiela Guo, transfers custody to immigration bureau

Shiela Guo, the supposed "sister" of dismissed Bamban, Tarlac mayor Alice Guo, was released from Senate custody on Tuesday after the Committee on Women investigating illegal POGOs lifted the contempt order against her.

"Shiela Guo, the Senate's contempt order on you is lifted and I direct the OSAA (Office of Senate Sergeant-at-Arms) to transfer your custody to the [Bureau of Immigration] pursuant to the mission order issued by the Bureau against you," said Sen. Risa Hontiveros, chairperson of the panel.

Shiela was cited in contempt and ordered arrested on July 13, along with Alice and

other individuals, for their failure to attend its probe.

It was later discovered that the Guo siblings had fled the Philippines in the same week.

Shiela was arrested in

Batam, Indonesia in August, and was turned over to Senate to attend its hearings. She faces complaints before the BI for alleged immigration violations.

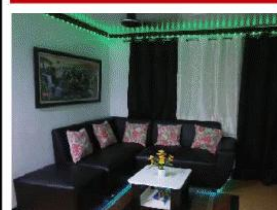

Joshua says boxing career 'far from over' after Dubois defeat

Joshua was aiming to become a three-time world champion by claiming the IBF world heavyweight title on Saturday but was knocked out in the fifth round in front of a record-breaking official attendance of more than 98,000.

The 34-year-old was

floored four times by Dubois and many people called for Joshua to retire afterwards.

But the British former Olympic champion released a video on X on Monday saying his journey in boxing is not over yet, with a potential rematch with Dubois as well as another all-British clash with

Tyson Fury options in the future.

Joshua said he was determined to take the positives from the situation despite his mauling -- the fourth defeat of a 32-fight career.

"What a rollercoaster journey, but do you know what the problem is? It is far

from over yet," he said.

"We've done it once, we've done it twice, doing it a third time hasn't been easy but I believe it is something I can achieve. It's about making the right steps forward, working hard, improving and it has to come from here (heart) more than anything.

"It's only been a day but I know when I sit back I know I've got a lot of this (heart), thanks for your support, thanks for being on this rollercoaster journey with me.

"Keep your seatbelts tight because deep down in here I know we have a lot more to bring to this game."

Alcaraz fears tennis tour grind will 'kill us'

The 21-year-old French Open and Wimbledon champion is currently taking part in the Laver Cup, his 14th tournament of the year.

Before arriving in Berlin the Spanish star had already played 50 singles matches in 2024, winning three titles and also collecting a silver medal at the Paris Olympics.

"Probably they are going to kill us in some way," Alcaraz said Saturday after defeating Ben Shelton in straight sets at the Laver Cup.

Alcaraz said that players had different opinions on the topic, but in his view "the calendar is so tight," adding "right now there are a lot of injuries."

"Right now a lot of good players are going to miss a lot of tournaments because of that."

He added that the crowded schedule meant he sometimes struggled to motivate himself on the tour.

"Sometimes, you don't want to go to a tournament. I'm not going to lie -- I have felt this way a few times already."

"Sometimes I don't feel motivated at all. But as I've said many, many times, I play my best tennis when I smile and enjoy it on court. That's the best option to keep motivating (myself)."

At the US Open, where he won his first Grand Slam title in 2022, Alcaraz suffered a shock second-round exit to 74th-ranked Botic van de Zandschulp.

He admitted he had blundered by not taking a longer break between the Olympics and New York.

At the Paris Games, he lost an emotionally-draining gold medal match to Novak Djokovic, just weeks after sweeping the Serb off court to successfully defend his Wim-

bledon title.

"I took a little break after the Olympic Games. I thought it was enough. Probably it wasn't enough. Probably I came here without as much energy as I thought I was going to (have)," he said after his US Open horror show.

"I have to think about it and I have to learn about it."

- "ATP doesn't care" - World number two Alexander Zverev, also playing at the Laver Cup, agreed with Alcaraz and demanded action.

"The ATP doesn't care about our opinion -- it's a money business," said the German.

"It's the longest season in sports. It's unnecessarily long. We have an unnecessary amount of tournaments."

Asked if the players would strike, Zverev said "we're not allowed to boycott, we get fined if we don't play tournaments," adding "the tour goes on without you."

"We need to do something about it. It's not an easy solution, but a solution which needs to be made."

Alcaraz and Zverev will not finish their seasons until late November when the Davis

Meanwhile, Alcaraz said he hopes he and Jannik Sinner can carve out a storied rivalry like that of Djokovic, Rafael Nadal and Roger Federer.

"I hope so," Alcaraz said when asked if he and world number one Sinner could emulate the dominance of the "Big Three" who amassed 66 Grand Slam titles between them.

"A lot of people talk about it. And I hear it, I'm not going to lie. I hope that our rivalry is going to be almost like what the big three had during their whole career."

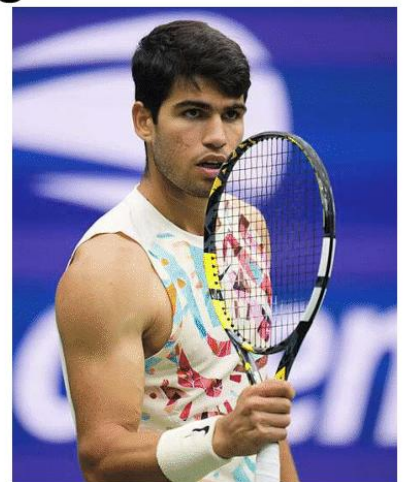
In 2024, Alcaraz and Sinner each won two Grand Slams, making it the first year since 2002 when neither one of Federer, Nadal or Djokovic won a major.

"Hopefully we're going to keep going like that, fighting for the great tournaments, sharing great moments. He has pushed me to become a better player every day," added Alcaraz after a 6-4 6-4 win over Shelton that drew Team Europe level on points with Team World at the Laver Cup.
