# DOST Ilocos Region Highlights 2024-2025 Initiatives, Community Impacts: Sets Strategic Pathways for Region 1

The review was led by DOST Undersecretary for Regional Operations Engr. Sancho A. Mabborang, Assistant Secretary for Countryside Development Engr. Maria Teresa De Guzman, together with representatives from various DOST offices and regional

units, highlighting a coordinated, whole-of-organization approach in evaluating program implementation and strengthening public service delivery. DOST Ilocos Region Director Teresita A. Tabag led the regional presentation,

together with Assistant Regional Directors, Provincial Directors, and the assigned DOSTOneSCIGLAT team, demonstrating a unified approach to advancing science, technology, and innovation (STI)-driven public service. In his opening message,

Undersecretary Mabborang emphasized continuous improvement and alignment with national priorities, stating: "This is not an audit; this is a learning process...In the next two years, value yourself and be able to do your duty with respect and be able to listen. [so that] you can provide decisions that are based on science and data to help the communities."

Sa pulong balitaan ng kagawaran kaninang madaling araw, mismong si Justice Secretary Frederick Vida ang nagkumpirmang nakalabas na sa nabanggit na bansa ang puganteng dating mambabatas.

Ito aniya ang ibinahagi sa kanila ng awtoridad ng Czech Republic sa naganap na pakikipag-usap o 'meeting' nila ukol sa sitwasyon ni former Cong. Zaldy Co.

Aminado naman si Justice Secretary Vida na tanging impormasyon nakalabas na sa naturang bansa ang pugante

ang nakuha at wala ng iba pang ulat ang ibinahagi pa sa kanila. Dahil rito'y umaasa ang kagawaran sa hinihintay na pag-isyu ng International Criminal Police Organization ng 'Red Notice' laban sa dating mambabatas.

## Roque, tinawag na 'continuing pattern' ang tax evasion case laban sa kaniya para i-harass ang supporters ng Duterte admin

Tinawag ni dating presidential spokesman Atty. Harry Roque na isang "continuing pattern" ang kasong tax evasion na inihain laban sa kaniya at kaniyang co-respondents para i-harass ang supporters ng Duterte administration.

Binigay ni Roque ang pahayag matapos maghain ang Bureau of Internal Revenue sa Department of Justice ng tax evasion laban sa kaniya, sa kaniyang maybahay na si Mylah Reyes Roque, at Percival Sazon Ortega dahil sa tax violations kaugnay sa Bianchan Holdings and Trading Inc., isang kompanya na dating pagmamay-ari nina Roque at kanilang associates.

Sa isang statement, sinabi ng dating presidential spokesman naniniwala silang ito ay isang political motivated at layuning i-harass at i-pressure ang mga ibidwal na nakikitang sumusuporta sa nakalipas na administrasyon.

"These filings form part of a continuing pattern of actions which we believe are politically motivated and intended to harass and pressure individuals associated with, or perceived to be supportive of, the Duterte administration. We view these developments with serious concern as they raise fundamental issues regarding fairness, equal pro-

tection, and the impartial administration of justice," saad ni Roque.

Sa hiwalay namang statement, sinabi ng BIR na base sa imbestigasyon nito, lumabas na nabigo ang magsasagawa Roque at si Ortega na maghain ng kinakailangang tax returns at magbayad ng kaukulang tax due sa paglipat ng shares of stock at paagtas sa awtorisadong capital stock.

Subalit iginiit ni Roque na walang anumang shares na inisyu alinsunod sa anumang alegasyon ng pagtaas ng authorized capital stock. Dahil walang aktwal na issuance o subscription ng shares, iginiit niyang walang taxable event na magdulot ng pananagutan sa batas sa buwis ng Pilipinas. Philippine History Books

Saad pa ng abogado na ang anumang suhestiyon ng pananagutan sa buwis sa yug-tong ito ay walang batayan at masyadong maaga.

"We will address these allegations vigorously through all appropriate legal remedies and will fully engage in the proper judicial and administrative processes. We remain confident that a fair and impartial review of the facts will confirm the correctness of our position," saad pa ni Roque.

# DOST SOCCSKSARGEN Conducts SSCP Roadmap Consultations in Three Municipalities in Sultan Kudarat!

*Building Smarter and Resilient communities through Science, Technology, and Innovation.*



Sultan Kudarat - April 14, 2026 - The Department of Science and Technology - SOCCSKSARGEN, under the leadership of Regional Director Dr. Sammy P. Malawan, RABE CESE, through the Provincial Science and Technology Office (PSTO)-Sultan Kudarat led by Provincial Director Ms. Zenaida D. Guiano, MSc, successfully conducted a three-day consultation meeting for the formulation of the Smart and Sustainable Communities Program (SSCP) Roadmap across three municipi-



palities in Sultan Kudarat namely the Municipality of Senator Ninoy Aquino, the Municipality of Kalamansig, and Tacurong City. The activity was supported by EVFI Consultants Mr. Nicanor Villaseñor and Mr. Martin Orendain, who served as technical facilitators during the roadmapping process. It brought together key stakeholders, members of the Technical Working Group, and local government officials to collaboratively devel-

op a forward-looking roadmap aimed at transforming communities into smarter, more resilient, and sustainable localities. The PSTO-SK team, including Engr. Szalinah S. Mercado, Supervising SRS and Regional focal person for SSCP, facilitated discussions and ensured active stakeholder engagement throughout the activity.

The consultation commenced in the Municipality of Senator Ninoy Aquino, led by Municipal Mayor, Hon. Rafael George L. Flauta III. During the session, Mayor Flauta highlighted the municipality's priority on establishing e-Governance systems to improve public service delivery. He acknowledged that limited internet connectivity remains a key challenge but expressed optimism that this will be addressed soon. He also emphasized strengthening the municipality's coffee industry, recognizing its role as the coffee capital of Sultan Kudarat. This was followed by sessions in the Municipality of Kalamansig, under the leadership of Mayor, Hon. Ronan Eugene C. Garcia. Mayor Garcia presented a comprehen-

sive and well-prepared development direction, focusing on enhancing the municipality's coffee industry. Among his proposed initiatives are the establishment of a coffee processing center equipped with an optical scanner to support local coffee processors, as well as a coffee nursery capable of producing up to one ton per hectare annually.

The final leg of the consultation was held in Tacurong City, the identified pilot community for the SSCP, headed by the City Mayor, Hon. Lina O. Montilla, PhD. Mayor Montilla shared the city's readiness to implement SSCP initiatives, highlighting efforts to strengthen internet connectivity in partnership with the Department of Information and Communications Technology (DICT). She also noted that the bio-reactor project provided to the city is currently underway for operationalization. The activity underscores the strong collaboration between DOST and local government units in advancing sustainable development through science, technology, and innovation. The finalization and implementation of the SSCP Roadmap are expected to materialize before the end of the year.



## DA, inapura ang fuel subsidy at toll-free pass ng mga magsasaka at mangingisda bunsod ng taas-presyo sa langis

Inapura na ng Department of Agriculture (DA) ang pagpapalabas ng fuel subsidies at iba pang interbensyon para sa mga lokal na magsasaka at mangingisda upang maibsan ang matinding epekto ng krisis sa Middle East at ang patuloy na pagtaas ng presyo ng petrolyo.

Sa isang pulong balitaan sa Maynila, inihayag ni DA Assistant Secretary at Spokesperson Arnel De Mesa na mahalaga ang mga hakbang na ito upang maprotektahan ang parehong prodyuser at konsyumer mula sa tumataas na gastos sa abono at freight costs o transportasyon ng mga produktong agrikultural.

Ang nasabing aksyon ay direktiba umano nina Pangulong Ferdinand R. Marcos Jr. at Agriculture Secretary Francisco Tiu Laurel Jr.

Upang mapanatili ang daloy ng suplay ng pagkain, nagpadala rin ang ahensya ng abot sa 38 Kadiwa trucks sa lalawigan ng Benguet.

Layunin nitong direktang bilhin ang mga aning gulay ng mga magsasaka matapos mapilitang tumigil o magbawas ng biyaha ang maraming mangangalakal dahil sa mahal na krudo.

Biniyang-diin din ng opisyal ang malaking tipid na dala ng pagtanggap sa bayarin sa toll.

Mula sa dating rebate system, ipinapatupad na ngayon ang toll-free na pagdaan para sa mga accredited DA truckers sa mga pangunahing expressways tulad ng SLEX, NLEX, at SCTEX.



## Meralco, sinabing hindi kumikita sa 'Pass-through charges' sa kuryente

Nilinaw ng Manila Electric Co. (Meralco) na hindi ito kumikita mula sa mga "pass-through charges" sa kuryente at ang lahat ng sinisingil sa mga konsyumer ay dumadaan umano sa regulasyon ng pamahalaan. Ayon kay Meralco spokesperson Joe Zaldua, ang bawat item sa electric bill ay inaprubahan ng mga regulatory agencies bago ipatupad at ito rin daw ay bahagi ng sistemang sinusunod ng lahat ng distribution utilities sa bansa. Ipinaliwanag ng kumpanya na kabilang sa mga sinisingil sa kuryente ang generation, transmission, subsidies para sa ilang sektor, at iba pang government-mandated charges na direktang ipinapasa sa kaukulang ahensya at hindi napupunta sa kita ng Meralco. Ginawa ng kumpanya ang pahayag kasunod ng mga serye ng reklamo ng ilang konsyumer kaugnay ng pagtaas ng singil sa kuryente sa gitna ng krisis sa enerhiya, kabilang ang P0.64/kWh increase noong Marso at P0.53/kWh na dagdag ngayong buwan. Giit ng Meralco, ang kanilang sariling distribution charge ay hindi nagbago mula pa noong 2022 matapos itong bawasan. Dagdag pa ng kumpanya, patuloy silang magbibigay ng malinaw at tamang impormasyon sa publiko upang mas maunawaan ang breakdown ng kanilang electric bills at mapanatili ang transparency at accountability sa kanilang operasyon.

### ORDER

(18 March 2026)

Before the court is the instant PETITION filed by the petitioner, JOSEPH CO DYHENGCO, also known as JOSEPH C. DY or JOSEPH CO DY, through counsel, against the respondents, JULIE CHAN DYHENGCO also known as JULIE Y. CHAN or JULIE YABUT CHAN, THE LOCAL CIVIL REGISTRAR OF MANILA, and THE CIVIL REGISTRAR GENERAL OF THE PHILIPPINE STATISTICS AUTHORITY (PSA), for the judicial recognition of foreign divorce and correction of entry in the civil registry under Rule 108 of the Revised Rules of Court.

In the Petition, the petitioner prays for the following:

1. RECOGNIZING as valid in the Philippines the divorce obtained in British Columbia, Canada by respondent JULIE CHAN DYHENGCO also known as JULIE Y. CHAN or JULIE YABUT CHAN;
2. DIRECTING the Local Civil Registrar of Manila and the Civil Registrar General of the Philippine Statistics Authority to annotate the judgment recognizing the foreign divorce on the Certificate of Marriage with Register No. 88-17232; and
3. DECLARING that Petitioner to be capacitated to remarry under Philippine Laws.<sup>1</sup>

In support thereof, the petitioner alleged the following statements of facts in the Petition:

5. Petitioner was married to respondent Julie on 3 July 1998 at San Sebastian Church, Plaza del Carmen, Barangay 390, Manila, Republic of the Philippines. A PSA-certified copy of the Certificate of Marriage with Register No. 88-17232 is attached as Annex 'A'.
6. Out of the Marriage, Petitioner and Julie begot three (3) children, now adults, namely:  
a. Jordandino Chimson Chan Dyhengco, born on 18 August 1989;  
b. Jodaren Conti Chan Dyhengco, born on 15 December 1992;  
c. Josef Caleb Chan Dyhengco, born on 19 June 2001.
7. Julie obtained Canadian citizenship on 10 January 2001. A copy of Julie's Canadian Citizenship Card No. A8341377 issued by the Government of Canada is attached hereto as Annex 'B'. Likewise attached as Annex 'B-1' is a copy of Julie's Canadian Passport No. GL948800 issued 24 February 2015.
8. On 23 March 2023, Julie applied for an order of divorce from Petitioner with the Supreme Court of British Columbia, Canada, on the ground that the Petitioner Julie have lived separate and apart since December 26, 2021. A certified copy of the 'Notice of Family Claim' with Vancouver Registry No. E-230752 is attached hereto as Annex 'C'.
9. On 6 September 2023, the Supreme Court of British Columbia, Canada, issued a Certificate of Divorce certifying that Petitioner and Julie 'who were married at Manila, Philippines on July 3, 1988 were divorced under the Divorce Act (Canada) by an order of this court which took effect and dissolved the marriage on September 4, 2023'. Apostille copy of the 'Certificate of Divorce' with Vancouver Registry No. E-230752 is attached hereto as Annex 'D'.
10. Under Section 8 (2) (a) of the Divorce Act of Canada, a divorce may be granted if 'the spouses have lived separate and apart for at least one year immediately preceding the determination of the divorce proceeding and were living separate and apart at the commencement of the proceeding'. Section 14 of said Act further states that 'a divorce granted under this Act dissolves the marriage of the

spouses'. Apostille copy of the Divorce Act of Canada (RSC, 1985, c.3 [2nd sup.]) is attached as Annex 'E'.<sup>2</sup>
